In line with Kosovo's current focus of transitioning towards an energy future that is more sustainable, inclusive, reliable, and affordable, the Kosovo Compact focuses on addressing Kosovo's unreliable supply of electricity, a binding economic constraint for the country, through three projects.

Does Kosovo have a free trade agreement?

Kosovo is a signatory of the Central European Free Trade Agreement (CEFTA) through the United Nations Mission in Kosovo (UNMIK) and has a Stabilization and Association Agreement (SAA) with the European Union that serves, among other things, as a free trade agreement.
