**What is Poland's new energy storage scheme?**

The scheme has been brewing since 2024, with the final regulation published in the Journal of Laws of the Republic of Poland in March this year. It received European Commission approval, which authorised state aid of EUR1.2 billion in state aid to support at least 5.4 GWh of new electricity storage facilities.

**What is Poland doing about energy storage?**

Poland has just rolled out one of Europe's most ambitious energy storage programmes- a EUR980 million initiative that's set to transform the country's grid infrastructure. The Polish Ministry of Climate and Environment has finalised this landmark subsidy scheme, targeting over 5 GWh of new storage capacity by 2028.

**Does Poland have a new energy storage subsidy programme?**

The energy storage sector in Poland showed significant momentum even before the launch of this new subsidy programme. Through power market auctions for 2021-2028 and supplementary auctions for 2021-2025, contracts for energy storage with a total capacity of 9.5 GW were already wrapped up.
